Terms and Conditions

1. Because the Diploma in Spiritual Healing course consists of 4 modules over 1 year, an application indicates a commitment to all 4 modules. Since the group will be closed, i.e. no further students will be admitted, please be sure of both your time (and financial) commitments before submission of your application.
2. Payment terms are as detailed in the application form.
3. Students will be notified as soon as possible regarding the award of a place.
4. Payments may be made in cash or by cheque or direct bank transfer. Transfer details can be obtained from Emma Craig (emma@brendadavies.com). Please note all transfers should be marked "ISHSD" for reference purposes and net of charges. (i.e. charges are for the senders account.)
5. Cancellation policy: If a student has to cancel his/her attendance at the course, the following refunds will apply:
 - a. 15 - 28 days in advance of school start date - 70% of total paid
 - b. 8 - 14 days in advance of school start date - 40% of total paid
 - c. 7 days or less in advance of school start date - 20% of total paid

7. If a student starts the course and for any reason cannot complete in the original group, he/she may, on discussion with Dr Davies, either repeat or complete one or more modules in another location or at a later date.
